New urbanizations in Western China Development

The 10th Annual Conference of the Consortium for Western China Development Studies

Since its establishment in 2004, the Consortium for Western China Development Studies (CWCDS for short) has organized nine conferences on various issues concerning the development of western China. The initial conference was held in Chengdu in 2004 with the theme of "Towards a New Paradigm for Developing Western China: Meeting the Challenges of Sustainable Development and Globalization." The eight follow-up conferences continued to focus on the different issues of the western China development, including "sustainable and rural development" (Yinchuan 2005), "regional development and poverty alleviation" (Chengdu 2006), "the construction of harmonious society in poverty-stricken areas" (Guiyang 2007), "the assessment of development processes in western China" (Xi'an 2008), "retrospect and future prospects of western China development" (Lanzhou 2009), "ten years of western China development" (Chengdu 2010), "vulnerability and sustainability of western China development" (Chengdu 2013), and "eco-civilization and urban new districts construction in western China development" (Guiyang, 2014). The conferences have gained great support from the Office of Western China Development, State Council, and Prof. Jeffrey D. Sachs of Columbia University, a Special Advisor to United Nations Secretary General Ban Ki-moon, who has been a frequent participant of the conferences.

Since the launch of the Western China Development Strategy, with the acceleration of the pace of industrialization, urbanization in western China has experienced rapid development from a low starting point. By the end of 2012, the urbanization rate in western China was 44.9%, an increase of 16% compared to that of 2000, with an annual growth rate of 1.33% and the formation of three urban agglomerations of Chengdu-Chongqing, Guanzhong-Tianshui and Beibuwan. At the same time, it should be noticed that the level of urbanization in western China is still far below the national average level. The national urbanization rate and that of eastern and central China is 52.57%, 56.4%, 53.4%,

44.9% respectively. At the same time, there is a big interprovincial difference in urbanization rates in the western region with a highest rate of 56.98 in Chongqing Municipality and a lowest rate of 36.4 in Guizhou. The urbanization rates of Yunnan, Gansu and Guizhou are below 40%. Similar to other regions of the country, urbanization in western China is facing many challenges, including a large number of population transferring from agricultural areas to urban areas having difficulty integrating into urban society and becoming urban citizens; land urbanization being faster than population urbanization and an ineffective use of construction land; irrational urban spatial distribution, size and structure, not matching with resource and environment carrying capacity; low levels of urban management and service, and the "urban disease" problem increasingly becoming sharp; ineffective protection of natural and historical heritages, and urban construction lacking local features and the incompleteness of systems and mechanisms, hindering the healthy development of urbanization. This conference will discuss those issues on urbanization in western China and explore the new models of urbanization in the western China.

Southwest University, in association with CWCDS, the Western China Development Committee of Regional Science Association of China, and the Chinese Economists Society, Economic Research Journal, Journal of Management World, will host the 10th Annual Conference of the Consortium for Western China Development Studies in Chongqing, from 15th to 16th, June 2015.

- 14. Urbanization and rural protection
- 15. Housing security and transformation of squatter areas
- 16. Urbanization in ethnic regions
- 17. Urbanization in frontier regions
- 18. Urbanization: International experiences and lessons
